ANCHORAGE, ALASKA AO No. 2019-88

AN ORDINANCE ESTABLISHING THE ANCHORAGE STORMWATER UTILITY AND ADDING ANCHORAGE MUNICIPAL CODE SECTION 26.10.016.

WHEREAS, Section 16.01 of the Anchorage Municipal Charter authorizes the Municipality to establish utilities and to prescribe rules and regulations for their operation and management (to the extent not subject to regulation by the Regulatory Commission of Alaska (RCA));

WHEREAS, the need for a stormwater utility (SWU) has been addressed over the last 30 years in numerous reports, and reviewed by advisory groups and civic organizations;

WHEREAS, the Administration recommends retention of a consultant to address rate structure, service levels, and regulatory compliance;

WHEREAS, the Municipality has issued a Request for Proposal for professional services to assist in the planning, development and implementation of a stormwater utility; and

WHEREAS, the initial creation of the SWU as an entity for fund accounting purposes facilitates funding, borrowing, and potential recovery of capital expenditures if the SWU is subsequently implemented and approved by the RCA and Assembly; **now, therefore**.

THE ANCHORAGE ASSEMBLY ORDAINS:

<u>Section 1.</u> The Assembly hereby establishes the Anchorage Stormwater Utility, a municipal utility.

<u>Section 2.</u> Title 26 of the Anchorage Municipal Code is hereby amended to add new section 26.10.016 to read as follows:

26.10.016 - Utility status of stormwater services.

The Anchorage Stormwater Utility shall be regarded as a municipal utility for purposes of this Code.

<u>Section 3.</u> This ordinance shall become effective immediately upon passage and approval by the Assembly.

The need for a stormwater utility (SWU) has been addressed over the last thirty years in numerous reports and has been reviewed by advisory groups and civic organizations. In 2017, the Assembly authorized the work that resulted in the *Stormwater Utility Findings Report and Recommendations*, Municipality of Anchorage (January 2019). Throughout this process the Assembly received a number of presentations on the work and ultimately the full report in January 2019.

- The public involvement process during this initial phase provided valuable and thoughtful responses from the community. These responses included the need to understand what
- the rate structure would be for both businesses and homeowners, as well as the service
- level that would be provided by this utility. The next phase of work intends to answer both
- of those of guestions in detail prior to applying for a Certificate of Public Convenience and
- Necessity (CPCN) from the Regulatory Commission of Alaska (RCA) and before the
- 18 Assembly approves a more detailed ordinance with this information.

To develop the required information, the Municipality issued a Request for Proposal (2019P022) for a consultant to assist in the planning, development and implementation of SWU. However, it is necessary to first create SWU in order to establish the funding mechanism to pay for the consultant. In addition to creating an entity for fund accounting purposes and to provide funding for the consultant, the Administration will introduce a second ordinance that provides for a stormwater utility borrowing program for start-up costs and conital expanditures.
