**WHEREAS**, the voters of the Municipality of Anchorage in the April 2020 regular election passed Proposition 12 by a majority of those voting on the question, enacting an amendment to the Home Rule Charter Article IV, § 4.01 to require each of the six Assembly election districts to have two members, and adding a twelfth Assembly seat; and

WHEREAS, when the voters approved unification and formation of the Municipality of
 Anchorage with the adoption of the Home Rule Charter at the initial election of
 September 9, 1975, the Charter § 19.03 assigned letters A through K to designated
 Assembly Seats, which lettering is still in use today; and

WHEREAS, the Assembly reapportioned itself and added the twelfth Assembly seat when
it adopted a new Assembly election districts map with the passage and approval of
AO 2022-37(S-1), As Amended. The new Assembly election district maps are
immediately effective and to be used at any Municipal election after the April 5, 2022
Regular Municipal Election; and

WHEREAS, Assembly District 1, Downtown Anchorage, to be compliant with the "one person, one vote" and "fair and equal representation" principles of the Equal Protection clauses of the U.S. and Alaska constitutions, had to nearly double in size of population represented; and

**WHEREAS**, The new Seat L in District 1, to align with the staggered terms structure of Assembly seats with three-year terms, will have its first full term begin with certification of the regular election to be held in April 2025; and

WHEREAS, It is appropriate and recommended by legal counsel that Seat L be filled
 sooner, in fairness to the voters within the new District 1 boundaries, at a special election.
 The initial term for Seat L in District 1 will run from certification of the Special Election that
 is the subject of this Resolution until certification of the regular election to be held in April
 2025; and

WHEREAS, Anchorage Municipal Code section 28.20.010 allows the Assembly to call a
 special election for purposes of electing candidates to fill offices; now, therefore,
