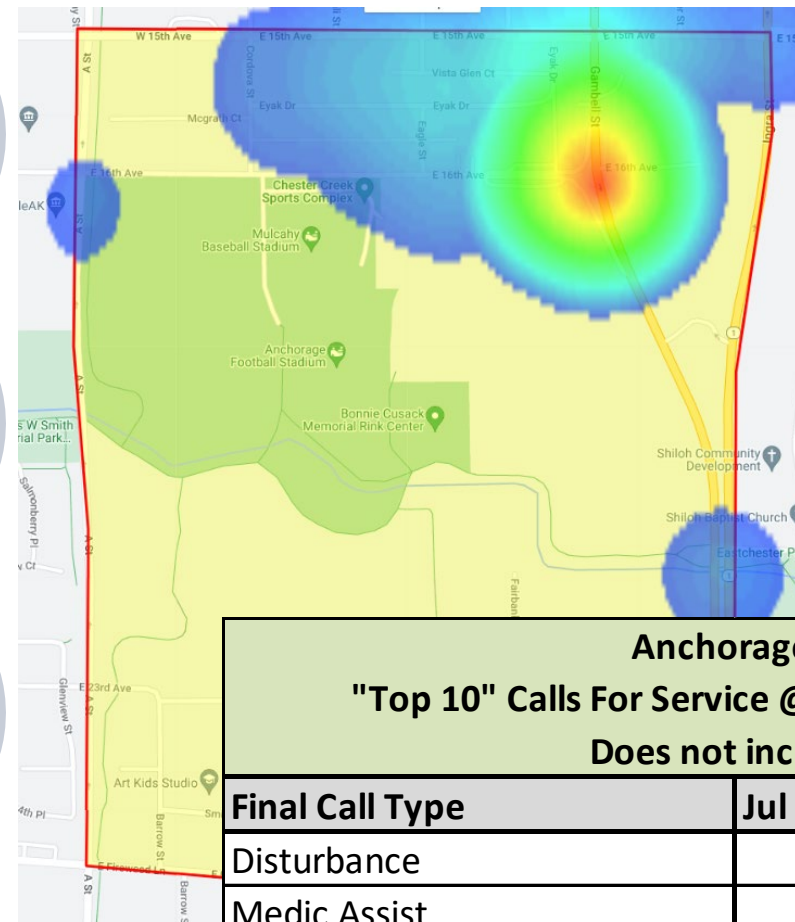
- From 01 July through 31 December 2022 there were a total of 393 CFS marked at 1600 Gambell St.
